SHARON TOWN COUNCIL Meeting Minutes, April 14th, 2025, at 7:00 pm

CALL TO ORDER and INVOCATION:

- 1. Mayor: Nicole Perkins presiding.
- **2.** Moment of silence/prayer

PERSONS WISHING TO SPEAK: Don Kropp

Nicole: Did everyone have a chance to go through your meeting minutes? This is the meeting minutes from March 10th for everyone to sign. I will pass this around. Is everyone fine with the minutes as written? No Changes?

All: No changes

MINUTES: Minutes of March 10, 2025, Regular Council Meeting recorded, ready to sign for approval.

Nicole: While we are passing this around, does anyone wish to speak here at the beginning of the meeting?

Don Kropp: Last Thursday we had a disaster at the town park. The stone you put in, is not solid. My wife came up with her scooter to watch the granddaughter and got stuck. If it wasn't for Scott Stone and my son, she would be there still.

Nicole: Yes, Scott told me about that, that is mainly because we have not had the funds to make the park handicap accessible.

Don: She went across near the fire department and immediately sank.

Nicole: The gravel was done thick in there to slow the cars down. We were having issues with people flying around the fire department going around the back. Objects were getting hit, so we went with heavier, thicker gravel to slow people down. We will look at it and see if maybe we can make a handicap parking space. There is an accessible entry on the Bell Avenue side.

Don: You may need to put Sakrete or something, so it stays solid.

Nicole: Then cars will start flying through there again. It is catch 22. The entry from Bell Avenue should be used.

Margarette: Maybe a ramp or something would be good.

Don Kropp: One more thing, when I was on the council, we always started with the Pledge of Allegiance, we are in the United States of America, and you have gotten away from that.

Nicole: Okay, we will add it back. Do you want to do it now, today? (Spoke to other previous council members and Mayor no recollection of Pledge of Allegiance.)

Don: You have started your meeting, go ahead.

Nicole: We do have our flags displayed, but we will add that to our agenda.

OLD BUSINESS:

1. Town Funding - Local, State, and Federal and Grant Opportunities

A. ARPA - funding. Funds must be spent by EOY 2026

Nicole: We are still going through our grant money, Charlie is coming in one day this week, it is time for us to send in our quarterly reports, so he will be helping with that.

Jay: Is he going to be here every day? I wanted to meet him; I didn't get to meet him. I was on the phone.

Nicole: I can see what his schedule is, I know he will be here trying to help us get everything uploaded to the state website. But I will have him check his schedule. He is also meeting with Don in Hickory Grove that day.

Brownie: What time is he supposed to be here?

Nicole: He sent me a text he said like 11:30 I think.

Nicole: I have lots of emails to go through, I will look for it. Also, this is not town related but John, Mr. Bojangles that used to do a lot of work for us through town, passed away this morning. So keep Marsha in your prayers.

Margarette: While we are praying, hospice is having to come every day now for Charles Bradley. It is very sad, they can't give you a time frame, but it can be days or weeks before he passes.

Nicole: Oh no, I thought he was doing good since he got home.

Nicole: So that is the state grants.

- 3. Maintenance Employee- Listing posted on Town Webpage. Applications being accepted-1 applicant from Hickory Grove called for details-never submitted resume or called back. 1 applicant from Sharon-Scott Stone.
 - A. Collect Town Trash-Trash to dumpster or setup acct with local trash company
 - **B**. Building Maintenance-as needed. Building checks/repairs.
 - C. Check Park equipment-monthly

- **F.** Misc. items as needed. Town & Community Center event setups/tear downs Nicole: Maintenance employee, we have had one person call us. We posted the job at the post office and town hall and our webpage. I had one gentleman call me about it. I asked him to come in and fill out an application or send in his resume. He just asked some questions about the job. He is a resident of Hickory Grove. I do not have his name now. So technically we have two names, I do not remember his right now, but it is him, Scott. We still need to meet about this and decide what we want to do about the maintenance person. That is mainly collecting trash, building maintenance, checking park equipment and maintain the fields at the ballfield and other miscellaneous items as needed. Helping at the community center events and stuff like that.

6. Town Administrator-Listing posted. Received resumes. Sent to council for feedback. Invited applicants to attend council meeting tonight.

Nicole: Town Administrator, we had several applicants. I sent those resumes to you to look at. We will talk further at our meeting, but I did invite them tonight to introduce themselves. Jennifer, would you like to speak?

Jennifer Ramsey: I'm Jennifer Ramsey, I've been in Sharon most of my life. (Could not understand any further)

Nicole: Thanks for being here, Nicole from Woodlawn St said she was coming that she was driving. She may come in later. Chelsie kind of pulled herself out, she has childcare issues. She would like to be able to bring her child to work with her. That is what she is doing now at Springlake. She works part time at Springlake. She would like to bring her child to work, we can't do that here. Dawn is out of town right now. Autumn talked to me at the grill; she did not come. We will have a meeting and talk about it further. I just wanted them to have a chance to speak like we did the other.

7. Town Tractors and Town Storage building cleanup.

- A. Backhoe County -pending County Council approval. Will be approximately 6 months
- B. Massey tractor with 4 in 1 bucket-Routine Maint done. Quote Hydraulic Maint

Nicole: We have lots of debris and other stuff that needs to be disposed of. There are the old ballfield lights that I talked to Hickory Grove about. They may be interested in buying them, they are waiting to see what the council wants to do. They may just buy new lights. They are recyclable but if anyone has any ideas about what to do with the lights let us know.

8. Town Maint-

a. Pump Station Maintenance- Quotes. Carolina Lift Station, McCall Brothers, 2 quotes received replace pumps station.

Nicole: We have gotten a variety of quotes on our pump station behind town hall. The two motors are old and may need to be replaced. We reached out to Carolina Lift Station (our previous maint vendor that has done work here before and we reached out to McCall Brother. They both have us a quote for maintenance and replacement of the two pumps. We had plumbers that gave us quotes but it is better to have someone that is more familiar with actual lift stations. The plumbers were a good bit higher than the maintenance companies. I can make copies of the quotes if you want them. We can talk about that more in our meeting.

Matt really likes the McCall Brothers. We have worked with Carolina Lift before so it may behoove us to go with McCall. Anyone have any ideas, questions?

Jay: How much were the quotes?

Nicole: Carolina Lift is \$4900, and McCall Brothers came in at \$4200.

Browne: That includes the maintenance agreement and the work that needs to be done.

Nicole: They maintain everything and come out and do annual inspections. That is their maintenance contract. That is \$4900, but to replace the pumps we would have to buy the pumps that is a different price. Their maintenance agreements are almost verbatim.

Jay: Maintenance covers the labor then its plus parts.

Nicole: It just says annual inspection, its like 5 pages. If we have an agreement with them and end up having to buy new motors, we get it at a cheaper price. We would have to purchase the pumps, and any other parts may be over the quote.

Browne: We have never had an annual maintenance agreement.

Nicole: We did have an agreement with Carolina Lift Station. We had that for 4 years. It was \$4000 a year. Those are 2 good companies for us to choose from.

b. Water Tank Maint. Southern Corrosion. Invoice pd Copy ? Washout not scheduled. Contact Mark.

Nicole: And we have a maintenance agreement with Southern Corrosion, they come out every year the check the paint, check for sediment, it gives us a better rate if something goes wrong with it.

9. Schedule Work Session-Date

- a. Procedures Hiring & Termination of Town Employees
- b. Town Purchasing Procedure/Town Ordinance.

Nicole: We have talked about this before, does anyone have a date to schedule a work session? Our next meeting will be May 12th.

Brooke: I can do it next week, with spring break, I'm not doing any school stuff. Another thing to talk about during our work session is maybe Browne is over rental properties let him get 3 quotes, I'm over sidewalks let me get 3 quotes for that. So it doesn't get into a mess like with the fence stuff. Maybe just add that in to our work schedule. It would help us all out.

Nicole: We should discuss our options during work sessions.

Jay: Like the fence thing, we all don't need to be working on it.

Brooke: That way it would keep from things getting so confusing. Then bring it in everyone look at it.

Nicole: Okay, we will add that to the work session.

Jay: Did we set a date?

Nicole: Monday, Tuesday or Wednesday.

Browne: I can do it anytime.

Nicole: Lets do April 23rd. Everyone got that on their calendar.

NEW BUSINESS

1. PMC/Tenet EMT Rental- Lease renewal Corey Glasscock email details.

Nicole: It is time for us to renew our rental agreement for PMC at the fire department. Oliver did some digging for us to find out what other people are receiving for rent. Oliver, do you want to talk about it?

Oliver: I never got a call back on one of the departments, but Newport is getting \$1200 right now but it is going up when they renew their contract. Fort Mill is a different world, but they are getting \$1650 I believe it was. Lelsie FD thinks it is \$1000 or more.

Jay: How much did you say York was going up?

Oliver: It was Newport, and they did not say how much they were going up.

Nicole: We have been stuck at \$900. When I talked to Beverly, she said they tried to raise the rent before but they were told no. They normally have a 5-year contract.

Don Kropp ???: Where are they going to go?

Nicole: Hickory Grove has a space. I talked to York County Council, and they said it would be good to have EMS in more areas but all we can do is ask and tell them what we would like to do.

Oliver: It has been the same for a long time. It is costing more and more for them to be there. The power bill for instance is over \$600 a month. A lot of that is because of them. You can't get them to close doors, turn lights off. It's like dealing with children. They tore up some doors. It is certainly y'all's call but I would shoot for \$1100. Either that and do \$1000 and then year 3 go up 5%, something like that.

Nicole: He said we can fill it out and negotiate. I'm under your mind set, we have not gone up in 5 years, not gone up in 10 years. So, I think we should at least go up to \$1200. What do you want to do? The contract locks us in for 5 years.

Browne: We are not any different than Newport. If they want to go somewhere else and get it cheaper.

Oliver: One of the reasons they ended up in Sharon and not Hickory Grove, to give you a little background on that. They have people that do studies and calculate and figure and all that. Sharon was picked for a reason. Most of the call volume is back towards York, they have a response time they are supposed to be there in so many minutes. The further away they get if they go back to York that jeopardizes their response times. Many of their calls is running back to York.

Margarette: So, they have a reason for wanting to be here too.

Browne: I don't think we would be out of line at all asking them to pay \$1200. All of the others are at that or more already.

Jay: \$1200 is the number.

Browne; Maybe then try to change in 3 years.

Oliver: I would at least try to do the \$1200 then do a 5% increase, that is my suggestion. As a side note, they haven't even been there this week, they have not had the staff. They are struggling like many others with staff for whatever reason.

Don Kropp: Maybe it is time to start putting cameras on the doors.

Oliver: Oh there is cameras.

Nicole: So everyone agrees to at least start at \$1200 to see that they do.

Brooke: I make the motion that we increase the rent for PMC to \$1200.

Margarette: I seconded the motion.

Nicole: All in favor.

All said aye.

2. Rental Units-Lease Agreements-discussion

Nicole: I talked to Browne about this earlier, we do have a company that wants to come in and rent the Community Center for their National Wild Turkey Federation event. They have a million dollar liability policy. Their request is part of their fundraising is they sell tickets and alcohol. They have law enforcement on site for their event so that is not our responsibility. Clover allows this when they have people sign lease agreements, they can have alcohol at events if they have liability insurance. Are you all ok with them doing that?

Browne: That would just be for that event.

Nicole: Are you okay with them doing that? We have had other people ask about alcohol there because we didn't think other towns were doing it.

Browne: And this is the Wild Turkey Federation?

Nicole: Yes, Chuck King is Regional Director of Upstate SC.

Jay: So how much do we get for that?

Nicole: Currently our rental rate is \$350 for the community center. We have lots of people that rent that area out.

George Ward: Are they wanting to do that once a year or something?

Nicole: It's a one-time thing. All in favor?

All said aye.

Browne: If they provide that certificate of insurance.

Nicole: They already have it but don't think he provided it to us yet. We can look at what Clover and York does for their rental spaces and kind of piggy back off of that. The only other thing with lease agreements is the flower shop. She was having some problems with staffing so she has not opened yet. I haven't talked to her this week to see how she is doing but she has lost a person. This will be her 3rd store, I hope we don't lose her. Right now businesses are having a hard time keeping people.

3. Events: Save the Date

Nicole: Dave wanted to consolidate these events and they had a really good turn out. They do need more craft people and produce so if you know someone let them know about our farmers market. It's the 1st Saturday of every month.

Margarette: Is there a charge to set up?

Nicole: No vendor fee at this point.

C. Community Center-Rentals

Nicole: The park rental is picking up since we have the new equipment.

Jay: When I was working the tea and lemonade stand at the opening event, I was really surprised at all of the positive comments we got. It was all from people I did not know, that was kind of interesting. They just wanted us to know how pleased people are. I wanted to give that feedback to you all.

Nicole: Dave did a really good job, the chicken and bbq was really good, everyone loved it. There were 3 new sauces I got to try. There have been a lot of people at the park.

Browne: I have been working at the cotton gin the last few weeks and it is amazing how many little ones and even a few adults have been on the slide.

Brooke: I saw some grandparents with their grandkids at 7:30 the other morning.

Nicole: It has been good, we are getting lots of positive feedback.

Margarette: I know you are tired of me asking but are we going to fix the basketball goal?

Nicole: We have ordered the metal to fix the goal. We are not ordering a new goal we are trying to fix the old one.

Browne: It will be harder for them to break that metal.

Jay: Are we getting a metal backboard? I don't understand.

Nicole: Yes, we are fixing it with metal and not glass.

Jay: The backboard?

Browne: Using the existing frame and weld a piece of metal in it. Instead of it being glass it will be metal.

Nicole: Its sort of how we fixed the little kid one, used metal instead of glass. It saves us money. We asked what a new glass backboard would be and did not get a reply so we are doing this on our own.

Jay: The metal has been ordered and that's what we are waiting on?

Nicole: Yes.

George Ward: I have been asked by several people, why was the kids basketball goal was put where it is? The little kids can't play if the big kids are playing. It is interfering with each other.

Nicole: It was put in the middle, so they can play separately. I have seen more little kids playing on the court since we moved it than ever before. When the big kids are playing the little ones can't play. It's first come, first serve. The main issue is the big kids now want to play on the kids basketball goal and hang on it.

Nicole: Hillcrest is having their Block Party on May 3rd at Harmon Park.

Browne: What time does that start?

Nicole: They usually start at noon, I will verify with Brad.

F. 4th of July Celebration-Select date

Nicole: We said July 12th. Anyone wishing to speak? Any concerns?

Doris Thomas: I had family visiting in town last week and they were commenting on how good the town looks.

Margarette: Oh, good very nice to hear.

Doris Thomas: Some of them have not been here in 20 years.

Nicole: I put out a Facebook post asking people what kinds of changes people would like to see happening in town. We got lots of good feedback on that. You may want to go look at Facebook and see some of the comments. York is doing a revitalization so I just shared their post. What would make you excited to have? One of the comments is a splash pad, York has one. That would require lots of maintenance. We don't really have the funds or someone to maintain it but that was something big that was mentioned. With us being on well water, we need a water source. See what your thoughts are about maybe making some changes. There is a lady at the farmers market, Elysian Flowers talked about maybe putting some wildflowers out to help with the bee population and help stop the erosion at Harmon park on that hill. Also, people are interested in a community garden. I don't want to do that but it is a good idea. Not Harmon Park, it is at Rainey Park for the wildflowers.

Browne: When you said Harmon Park, that makes more sense, it would be pretty at Rainey Park. There is a piece of the roof of the gazebo missing. Maybe we can get Adam over there to fix it.

Nicole: Nancy said there are kids that go over there throwing balls at the roof. It needs some kind of water seal. The kids are rough over there at that gazebo.

Browne: I know they tore up some of the benches over there. I have noticed there is a triangular piece that come off over there that is laying on the roof. Adam could look at it. The other question that came up the other day is what are we going to do to finish off the shed at the new bathrooms?

Nicole: Shane offered to give us siding to put up there to cover that. We would have to pay someone to install it.

Browne: It would be nice if Shane volunteered to put the siding up.

George Ward: When are the bathrooms going to be open?

Nicole: We am waiting for a plumber to get it hooked up.

Browne: Which plumber is that?

Nicole: We have 2 quotes right now. The bathrooms are not going to be open all the time. They will be open in the daytime and closed at night. They are not going to be open 24 hours like the town did before. The reason we have them is for events. Right now, the porta-johns are good, they come in clean them we don't have to worry about it. It was a lot to open and close the bathrooms every day, the bathrooms were demolished.

Nicole: The porta-johns work very well; we don't really want to take those out. We mainly wanted to have them for special events. If they rent at the park they can access them that day, they will clean up and make sure everything is fine. And overflow bathrooms for the f

Nicole: Does anyone have anything else? Oliver?

Oliver: AT&T did some work and supposedly fixed it would be harder for people to climb up there. Well we talked about siding for the park for the bathroom. Couple things, it will be Christmas before we know it, if we are going to do decorations we need to do something on that. Someone said that Mac looked at the contract with Duke, in my opinion that would be the way to go. Yall know those decorations are getting old, brittle and more

challenging to fix. Even if we are going to put those back next year we need to do something about the brackets. Some of them are falling off, some are loose. The eyelets are in bad shape. We had to change about 10 or 12 out and that is becoming a regular thing to change them out. If we can get in under their contract that would be good, I'm not getting any younger. It is getting more difficult getting help with it.

Nicole: We need to sign the contract.

Oliver: You can always start small and then expand.

Nicole: The older wreaths we may want to keep and do a little something near town hall. How much trouble to keep the wreath here?

Oliver: We had to have someone out here to work on them 2 or 3 times last year.

Nicole: Then we should probably just get rid of them.

Oliver: That is your call, the bulbs are old. Everything is going to led now.

Jay: Maybe we can talk about it in the work session. I would think maybe allocate some money to that program. That way we can upgrade the decorations not all at once or just update a little every year. May be time to start all over again if we did it that way.

Nicole: I know Smyrna just got new decorations over there; Carla gave me the name of their vendor. The time to buy it is in the summer. We can talk about it more. LED is the way to go. I have seen Smyrna and Hickory Grove and their decorations are not that heavy for the fire department to put up. We could maybe start the main strip and later on we could go farther down each street. They are like \$500 or \$600 each but you can get them for half price.

Jay: If we could replace a few every year and keep that program going we could get them all replaced.

Nicole: We will get some vendor information together.

Jay: What about the outlets, we need to get those under Duke contract?

Oliver: There are 2 different systems the town has now. There is a pole right here near Scotts to Brownies to the Hill building that is all on one circuit that is metered. Duke has wire running currently for that we can plug in to. But when you go to the ARP church to the

town entrance those are all individual circuits, individual outlets. That's the ones we need to work on all the time and Woodlawn St. So we have 2 different kind of hybrid systems right now. My suggestion if you were going to get Duke to do it have an overall major plan of how far out you want to go this year and then do the outlets for the whole system and add to it each year.

Browne: Would you keep the old system that is metered?

Oliver: I would say as old as it is that you let Duke take care of all of it. The wiring needs to be replace, if the wind blows it may be a short. The other thing is we want to toot our own horn. We got our ISO back a little over a month ago. If you are not familiar with ISO that is our Insurance Services Office, they do survey classifications every 4 to 5 years. We stayed at a 4 and that is good for a little department like ours. We are very happy that we stayed a 4. That is what your insurance rates are based from. The ratings are from 1 to 10. Ten means you have no fire protection. One is you have outstanding fire protection. For Sharon we have challenges of getting water, so water source is a problem. We are very pleased. There is a lot of work that goes into it. Training, personnel, how many people respond to calls, a lot of paperwork that goes on behind the scenes that no one sees. It is a pretty big ordeal for us and we are pretty pleased.

Council: Thanked Oliver for job they do.

Nicole: We announced the Fire Department rating in our newsletter.

Margarette: Oliver before we jump to Christmas, what do we need to talk about for our 4th of July celebration?

Oliver: That is a good point. What are your plans?

Nicole: We have is scheduled for July 12th. Last year Danny Dickerson got the fireworks for us.

Oliver: Yes but there is a lot of paperwork that goes with that. You have to get state approval.

Margarette: Yes, Tina learned that the hard way.

Nicole: Speaking of Tina, she is still coming in 2 days a week. She is coming in this week to turn in report for our grants. Charlie coming in to help her with that. I will ask her about Danny Dickerson paperwork. That is not in my wheelhouse.

Jay: Talking about paperwork, what about QuickBooks? We going to try to switch over to that at the end of our fiscal year?

Nicole: It will depend on when we can do that. Right now, we are trying to hire someone and make sure everyone is trained. Depends on what we get situated.

Jay: The first step might be to buy the new system.

Nicole: We don't want to jump the gun. We need to train the person to know the current system before we switch.

Jay: Which comes first, the chicken or the egg?

Nicole: We can buy it, but it may sit here for 6 months before everyone is trained to use it.

Jay: If we get it, we are more obligated to try to use it. Does that make sense?

Nicole: I understand. But, there was a "we" in there, we have got new people that are going to be coming in learning stuff. We have to get them up and running on the old system before getting them on the new system.

Jay: Would it be possible for them to just start on the new system?

Nicole: We can't do that in the middle of the year.

Jay: The plan was to start June 30th. When we first started talking about this before Christmas, it was wait until the end of our fiscal year and now that we are getting closer we are talking about getting everyone trained. Is that the way it is going to work?

Nicole: Jay at this point I don't know. There are a lot of things that need to be done for the town that require help.

Jay: Help with what?

Nicole: There are a lot of items to consider.

Jay: I'm here to help.

Nicole: We can buy it but I don't think it's needed at this point.

Margarette: I can't, I don't know anything about it.

Jay: The accountant said you need to get a new accounting system. Right? That was my understanding. He said we need to get QuickBooks.

Nicole: No. He said whatever we were used to. If we wanted to switch, they don't tell us what system to use. Even Hickory Grove isn't on QuickBooks. They are on Quicken.

Question from someone in audience – unable to understand. ???

Jay: I use Peachtree which is a competitor of QuickBooks. A double entry accounting system.

Browne: I use Business Works which is a competitor of QuickBooks.

Nicole: I've got a note, we will look in to it. There is a lot going on right now, which there is always a lot going on. Anything else?
